The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI for mobility to ES and no later than 5 weeks for mobility to CZ.
