The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme. ### Termination of the agreement

The agreement can be modified or terminated unilaterally, as long as at least a one academic year notice is given. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
